Sample summary

Seabed mining could impact the marine ecosystem as possible outcomes of this unparalleled invasion is unclear. Machines drawing out ocean floor nodules can harm fragile ecosystems housing dependent lifeforms. Freeing carbon embedded in the ocean floor could disrupt the ocean's capacity to absorb carbon. Noise and light created during mining can disturb natural habitats, altering how animals hunt and mate. **In response**, various stakeholders have advocated a temporary halt in mining. Some banks stopped lending money to ocean-mining companies while some celebrities have voiced opposition to deep-sea mining.
