- 1 Fig. 1 shows offshoring destinations as well as locations with offshoring demands in 2010.
 - (a) Name the countries with the highest demand for offshored services. [1]
 - (b) Compare the different offshoring destinations as shown in Fig. 1. Use evidence from Fig. 1 to support your answer. [3]
 - (c) Using a country you have studied, outline **two** reasons why it was chosen as an offshoring destination. [3]
 - (d) To what extent do offshoring destinations benefit from the offshoring of services? [5]

Population Issues and Challenges

- 2 Fig. 2 shows the annual flow for immigrants from selected countries into USA (a DC) from 2000 -2013.
 - (a) Describe the immigrant flows as shown in Fig. 2. [5]
 - (b) The government proposes to restrict the arrival of immigrants with lower education status. Outline what effects such a policy would have for USA (a DC). [7]

- 3 Fig. 3A and Fig. 3B show the list of top ten megacities in 2014 and the list of projected top ten megacities in 2030 respectively.
 - (a) What are *megacities*? [1]
 - (b) Compare the list of megacities in Fig. 3A with that in Fig. 3B. [4]
 - (c) Explain **one** reason why the prediction shown in Fig. 3B can be seen as inaccurate. [2]
 - (d) Using a city you have studied, explain how economic forces may affect the urban zoning of its Central Business District (CBD). [5]

- 4** Fig. 4 shows Human Development Index (HDI) and the ecological footprint (EF) for selected countries in 2008. The figure uses the 90s definition of HDI derived by the United Nations (UN).
- (a)** Define the term *sustainable development* and explain the term with reference to Malthus' view on population and resources. **[5]**
- (b)** Using evidence from Fig. 4, describe the relationship between HDI and EF. **[3]**
- (c)** Explain how useful HDI (as defined by UN in the 90s) is in understanding a country's EF. Support your answer with evidence from Fig. 4 and your own knowledge. **[6]**

 - (b)** Evaluate the view that low levels of fertility are difficult to reverse in developed countries. **[16]**
