- 1 Figure 1 shows star diagrams which illustrate the occupations of people living in the same village in 1930 and in 2000. The village is in an accessible area in Southern England.
 - a) Describe the changes in employment that have taken place since 1930. [4]
 - **b)** Suggest reasons for the changes in employment. [8]

Population Issues and Challenges

- **2** Figure 2 shows the changes in the total populations and age structures of selected global regions.
 - Calculate the dependency ratio for North America in 2050 and show your working in detail.
 - b) Sketch a possible pyramid of Europe for the year 2050 and briefly describe it. [4]
 - c) Using Caldwell's Wealth Theory, account for the changes in the young population in Sub-Saharan Africa from 1950 2050. [6]

Urban Issues and Challenges

- 3 Figure 3A shows the number of new homes built on greenfield and brownfield land in England between 1991 and 2001. Figure 3B shows possible locations for new housing in greenfield and brownfield areas.
 - a) Using evidence from Figure 3A, describe how the use of greenfield and brownfield land for construction of new homes changed between 1991 and 2001. [3]
 - **b)** Suggest reasons for the trends describe in part 3a) [4]
 - **c)** You are a planning officer with the power to make decisions about land use within the city illustrated in Figure 3B. Two alternative proposals have been submitted for the derelict land. One proposal is a high-class housing development and the other is for a flagship retail project.
 - State for which proposal you would decide to grant planning permission and outline briefly the reasons for your decision. [5]

- 4 Figure 4 illustrates a cartoon at the time of the Johannesburg World Summit in 2002.
 - a) What would be a possible headline for this cartoon? [1]
 - **b)** Give evidence from Figure 4 to justify your headline in part 4a). [2]
 - c) Using specific examples, explain how some policies adopted by international regulators are responsible for the scenario depicted in Figure 4. [6]
 - **d)** What other reasons account for the scenario illustrated in the cartoon? [5]

- **5 Either a)** Outline the causes of the emergence of the New International Division of Labour (NIDL). [9]
 - b) How far do you agree that development is best measured by the populace's Gross National Product (GNP)? [16]
- **5 Or** a) Analyse how new technology has changed the production and labour process. [9]
 - b) 'In recent years, companies have been outsourcing their production and services.'
 Why has this policy been adopted and with what consequences for the companies?

Population Issues and Challenges

- 6 Either a) Discuss the detrimental effects of an ageing society on the service provision and the sustainability of communities in Developed Countries. [9]
 - b) According to one United Nations projection, total world population will pass 8 billion in 2028. To what extent do you agree that such a prediction is of little value to governments? [16]
- **6 Or a)** Explain how distance may operate as a constraint on transnational migration. [9]
 - b) With the use of examples, consider the issues of government planning in the management of population growth in Developed Countries. [16]

Urban Issues and Challenges

- **7 Either a)** Using examples, compare the terms 'megacities', 'primate cities' and 'world/global cities'. [9]
 - b) "Squatter settlements are a positive form of settlement." Discuss this proposition in reference to housing strategies in Less Developed Countries (LDCs).
- 7 Or a) Discuss the causes of homelessness in cities of developed countries. [9]
 - b) "Historical factors are the main determinant of contemporary urban structure." With reference to urban areas you have studied, assess the extent to which this is true. [16]
