- Figure 2 shows employment in the major maguiladora centres along the border between the United States and Mexico in 1996.
 - A maquiladora is an assembly plant to which components and materials from the United States are imported duty-free, providing the products are then exported.
 - Suggest reasons for the concentration of *maguiladoras* in the border zone. [6]
 - b) Assess the impacts of the growth of the maquiladoras on the Mexican economy.

 - a) Using information from Figure 3,

 - b) Explain how population movement has contributed to social segregation within an urban area.
