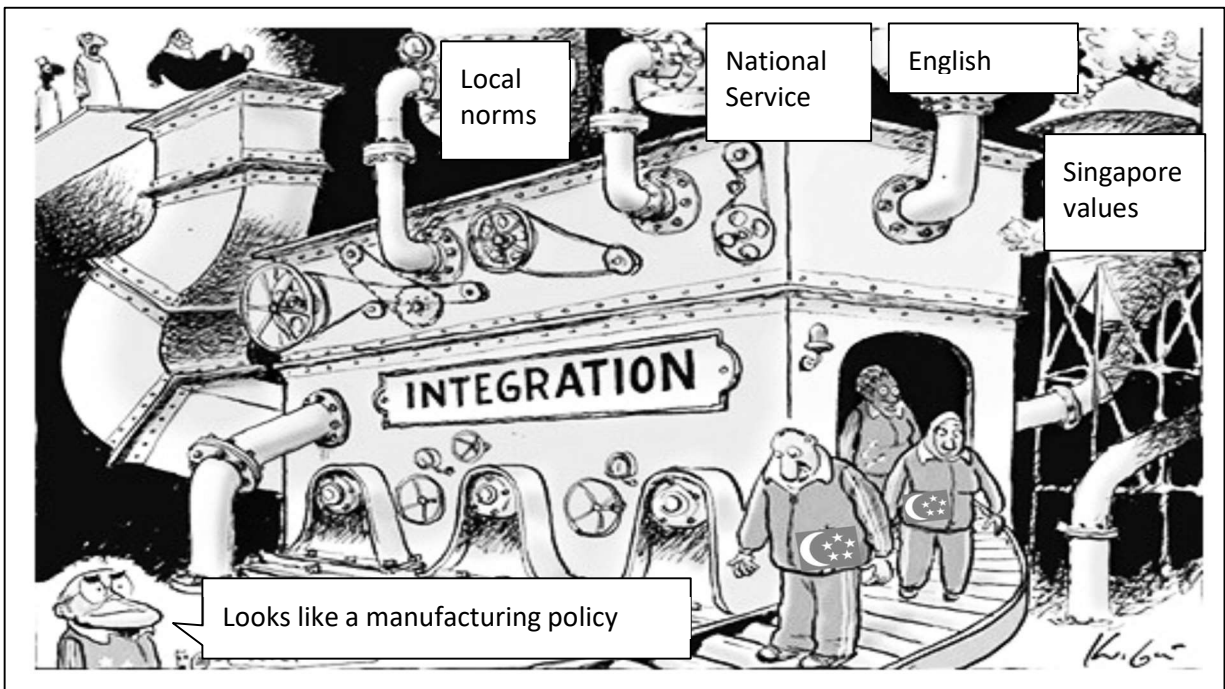
BACKGROUND INFORMATION

Read this carefully. It may help you to answer some of the questions.

As Singapore becomes increasingly diverse, it is important to ensure interactions amongst different groups in society are meaningful. This will allow Singapore to continue to foster and strengthen harmony in society. Globally, there is a trend of increasing prejudice and discrimination. The September 11, 2001 terror attacks in the United States has unfortunately led to security agencies stereotyping Muslims in the name of anti-terrorism preventive measures, leading to a wave of Islamophobia. More recently, shootings that took place in a mosque in Christchurch, New Zealand on 15 March 2019 left many Muslims wounded and dead. The shootings were carried out by a lone gunman and were broadcasted live on social media. Such an attack can place a severe strain on relationships in a multi-religious society like Singapore if religious harmony is not strengthened. Authorities and online platforms are also realising they need to exercise extra vigilance to prevent online tools from being misused by unscrupulous users. These examples show that threats to our inter-religious harmony are prevalent. In light of this, how can religious harmony in Singapore be safeguarded?

Study the following sources to assess how religious harmony in Singapore can be safeguarded.

Source A: *This cartoon was posted in an Australian professor's blog post, 30 Jan 2011. The post was about his research on the integration policy in Singapore.*



Source B: *An excerpt from the Singapore Interfaith Youth Circle Group posted on Facebook, 15 March 2019.*

For the first time in a long time, New Zealand's terror threat level has shifted to high. This is a country whose threat levels are generally regarded as very low.

As much as our hearts and prayers are with them, we would also strongly encourage every Singaporean to reflect on where we stand as a community and a country today.

This peace we have simply cannot be taken for granted or be left to chance. The government alone cannot be left to deal with the aftermath of a terror attack. How prepared are we to stand together and ensure our social fabric stays stronger than ever before? How ready are we as individuals and communities to withstand this?

Source C: *From a research done by an independent research institute based in Singapore, published in 20 March 2019.*

In a random sampling of 1,800 Singaporean residents, seven in 10 respondents in Singapore said they feel that people from different religious backgrounds can get along when living close together.

Even so, around 15 per cent of people said they found Muslims at least somewhat threatening. This was higher than what was reported for any other religious group. Those who live in private estates were more likely to see Muslims as threats compared with those who live in public housing. On the other hand, those who had more trust in *secular institutions were less likely to think that way.

*Secular: The separation of state from religion.

Source D: *From a speech by President Halimah Yacob, at a conference in Beijing, China. It was published on channelnewsasia.com in 16 May 2019 with additional commentary.*

President Halimah Yacob said that: "Religious harmony is always going to be a work in progress, noting that Singaporeans have become more fervent in their religious convictions. It is important that our people are good citizens of Singapore, at the same time as they are good Buddhists, Taoists, Christians, Muslims, or Hindus. While religion is seen as a positive factor that can strengthen society, the country is a "strictly secular state."

The country's Constitution was recently amended to ensure minorities will be regularly elected as president. The country also has strict laws to prevent the unfair criticism of other faiths and the mixing of religion and politics.

Source E A cartoon depicting religious leaders of different faiths published on the webpage of the Commitment to Safeguard Religious Harmony website, June 2019.



Source F An extract from an article published on channelnewsasia.com, 19 June 2019

Bishop Terry Kee, the President of the National Council of Churches of Singapore, said religious leaders had discussed the need to enhance existing declarations of religious harmony and bring something practical to the table for years.

He added that his community will have to tackle the issue of Christians sharing about their faith when it is not welcome. "We always affirm that it is our right to embrace our faith, to practice and also to propagate (it). However, we have no right to denigrate or ridicule other faiths. We have to be sensitive as to whether it is the right thing to do at that point in time."

He chooses this cartoon to make his point. The cartoon depicts many people going through a machine that will pump them with elements such as "local values", "English", and "National Service". These are common norms and experiences that help to bond Singaporeans. By using a machine to infuse them with these elements, it is a systematic way of integration. The people that come out have a Singapore flag on them and are dressed alike. Depicted on an assembly line, they look just like manufacturing products. This suggests that they are "products" of a system. Instead of positive social interactions which helps to integrate people of different backgrounds, and allows them to retain their unique differences, it seems like they become similar products after going through the machine. The people are also depicted looking surprised at what they have become. The caption also says "Looks like a manufacturing policy". This is a critical portray of integration as it seems like integration is manufactured in Singapore and not actually present.	4-5

The government alone cannot be left to deal with the aftermath of a terror attack.” As Source C clearly shows, even though 7 out of 10 Singaporeans feel that people from different religious backgrounds can get along when they live together, there are still 15% of 1800 Singaporeans who are threatened by another religion, Islam. This shows that more has to be done, and Singaporeans need to reflect upon their own prejudices in the face of such an incident. This attack also highlighted that terrorism is clearly not linked to any one group. But as Source C shows, there are still some people in Singapore who think that Islam is threatening, which supports the need for the reminder that Singapore citizens should stand together regardless of their religious beliefs, else an attack that happens elsewhere in the world will also have the potential to divide us in Singapore.</p>	4-5

This shows that the President agrees that religious harmony needs more effort as Singaporeans "become more fervent in their religious beliefs", which means that even as Singaporeans become more religious, they need to put their identity as Singaporean citizens first, instead of their religious identity. Therefore more efforts need to go towards this. OR	3

	<p>I think that the researchers in Source C would disagree with Source D in saying that government measures to foster religious harmony are focused on the right areas.</p> <p>Source C: "Researchers found that those who live in private housing estates or landed property were more likely to see Muslims as threats compared with those who live in public housing." It is clear from research data that the type of housing a person stays in may influence how they feel about other religions. So, the researchers will take away that more needs to be done for housing policies to integrate different religions together.</p> <p>Source D: "The country's Constitution was recently amended to ensure minorities will be regularly elected as president." This shows that the President may feel that changing government policy and laws may be more effective in fostering religious harmony.</p>

I do not think that the government has the most important role in building a harmonious Singapore.

Sources B, E, F disagree that the government has the most important role.

Source B mentions: The government alone cannot be left to deal with the aftermath of a terror attack.:" and questions "How ready are we as individuals and communities to withstand this?" which shows that citizens and the various communities should also play their part in fostering religious harmony so that nothing can affect the harmony in our society.

Source E is a cartoon published on the webpage of the Commitment to Safeguard Religious Harmony website, June 2019. This commitment is led by the religious leaders of different faiths, which clearly outlines that religious leaders of different faiths should role model of how religious harmony can be fostered.

Source F mentions that "religious leaders had discussed the need to enhance existing declarations of religious harmony and bring something practical to the table for years." This shows that religious leaders are clearly aware that they are the ones who can influence their own communities, not just the government.

However, Sources C, D, A do agree that the government plays the most important role.

The research in Source C shows that those who lived in public housing, with its mixed housing policy had less prejudices against Muslims. It also shows that those who trusted government institutions which were secular felt less that way. This clearly highlights that housing policies by the government makes a difference to how people feel about social cohesion in the society, and the amount of trust they have in government institutions and their ways of handling state affairs also matters.

In Source D, the President mentions that "The country's Constitution was recently amended to ensure minorities will be regularly elected as president. The country also has strict laws to prevent the unfair criticism of other faiths and the mixing of religion and politics." This shows that clearly, the President believes that with the government's approach to bridging religious divide matters, with the Constitution and laws in place, it highlights that all religions are treated equally in Singapore.

Source A is also reflective of the government's role. While it is critical of our integration policies by mocking it as a "manufacturing process", it also highlights how important the approach taken by the government can be, in bringing about peace in the country, whether manufactured or otherwise.

With the New Zealand Christchurch attacks in mind, the aftermath of the terror attack had many people coming together to show solidarity with the Muslim community. For example, the Prime Minister in New Zealand wore a hijab while visiting the Muslim community to express her condolences. Other groups of people also followed her lead and wore the hijab. The haka was performed at several official and sporting events, in schools, and even at a gathering of bikers, to show the Maori community's support for the Muslim community. The Maori are the natives of New Zealand. With such an outpouring of support not just from the Prime Minister but also the people of New Zealand, it really showed the solidarity and resilience of the New Zealanders to stand united against terrorism. It can occur in entertainment such as movies, music and food. Cultural homogenisation can be positive because some homogenisation of some dominant foreign influences may have positive ideas such as in the American cultural exports that shares the themes of freedoms and individualism or the Korean cultural exports that share the themes of family values. These themes can be positive as it allows society to be exposed to new ideas that can enrich the discussions in society. Furthermore, cultural homogenisation also allows for shared culture which facilitates communication among people of different culture, potentially reducing conflict and tensions.</p> <p>Cultural homogenisation however can be negative where the cultures of a more dominant group imposes the ideals and misconception on others. It can be particularly negative if the dominant group propagates false or inaccurate portrayals of certain groups. This will create anger and resistance in such cases. For example, Kungfu panda an American movie portrayed Chinese culture superficially and inaccurate creating anger within the Chinese community. Furthermore, with the rise of cultural homogenisation, they maybe a dilution of local culture eroding national identify which can be negative for countries who strive to promote their national identity.</p>	5-7
