Note: When students do unreliability, and claim that source is biased, extremely one sided, they also need to mention what is the other slant that is not mentioned and both slants must be supported with specifics.

Source A cannot be used to agree with the claim because it has a motive which is to convince (P) the international community that the Nigerian government is effective in dealing with the Boko Haram threat (M) so that the international community would stop criticising the Nigerian government. (A) Because at that time, as the Nigerian government has been criticized for being slow and ineffective in dealing with the terrorist groups and for disrespecting human rights during the process of its investigations (S). Given this purpose, it would naturally paint a positive image of the government, focussing only on the strengths and successes of the government forces. Therefore it would be biased and hence unreliable and cannot be used to agree with the claim.

C) Balanced Conclusion/ resolution

It isn't just a summary of whether Singapore is inclusive or not but a CONNECTION needs to be made between both sides and if resolution given, again it should be specific about what can be done and by who.

(D) For instance, during the festive season, various cultural celebrations are held, such as the Lantern Festival celebrated by the Chinese community, which includes the release of lanterns and mooncake sharing. Similarly, the foreigners celebrate Christmas with open houses where families invite friends and neighbors, exchange gifts, and share festive meals. (E) These events not only showcase the rich tapestry of cultures but also encourage participation from all communities, fostering a sense of unity and appreciation for one another's traditions. As a result, with these events as opportunities, foreigners and locals have increased opportunities to interact, find out more about local cultures and share their own cultures. (O1) This cultural exchange promotes social cohesion, (O3) as individuals learn to respect and celebrate differences, (O2) leading to a more harmonious society (O4) where diversity is seen as a strength. However, there are also challenges to living in a diverse society. For example, competition over public services such as transport overcrowding especially during peak hours. A specific incident in 2017 highlighted this issue when a viral video showed a local commuter expressing frustration over the packed trains, attributing the overcrowding to the increasing number of foreign workers using the same services. This incident resonated with many Singaporeans who felt that the influx of foreigners was straining public resources and diminishing their commuting experience. As a result such frustrations can lead to a sense of alienation among Singaporeans (O1), who may feel that their needs are being overlooked in favor of accommodating a growing foreign population(O2), making locals view foreigners negatively and blaming them for their problems (O3). Conclusion In conclusion, although Singaporeans have experienced many positive and negative interactions with immigrants, their experience has seen more benefits because many of the negative incidents are isolated exceptions and can be resolved in the short run. Locals and foreigners understand that these cases are not representative of all immigrants. In the long run, with these challenging issues resolved, more Singaporeans have positive interactions with foreigners in school and at their workplace and hence bring more beneficial interactions. Thus, in comparison, it has brought more benefits than challenges.
