BACKGROUND INFORMATION

A recent survey of the *Fortune Global 500** found that leaders who chose to invest in Artificial Intelligence (AI) tools expect to see significant growth in their companies. One example of an AI tool that has taken the world by storm when it was first released for public use on 30 November 2022 is ChatGPT. Within two months of its release, it reached 100 million active users, making it the fastest-growing consumer application ever launched. Some users are attracted to AI's advanced capabilities while others are concerned about its potential to cause disruption in various sectors. Indeed, the adoption of AI has both pros and cons.

Source B: *Minister for Education, Mr Chan Chun Sing's response to Member of Parliament, Mr Shawn Huang's question on how the Ministry of Education will manage the use of Artificial Intelligence (AI) bots such as ChatGPT in schools, 7 February 2023.*

As with any technology, generative AI tools such as ChatGPT present both opportunities and challenges. When used appropriately, these tools can support students in their learning when students have mastered basic concepts and thinking skills.

In their daily work, students are taught the importance of integrity and the harmful impacts and consequences of plagiarism. In addition, through daily interactions with students and from using multiple modes of assessment, teachers are able to gauge students' proficiency and detect uncharacteristic responses that could be AI-generated. MOE will continue to monitor the impact of these tools on learning and equip students with the skills and values to enable them to harness technology confidently and responsibly. Our approaches will evolve as we adapt to the use of new AI tool

Ben, said he applied for a second job only after realizing he could use the AI tool at work. From Toronto, Ben helps financial-technology companies market new products. He told Vice that ChatGPT had helped him do his job faster and more efficiently, which left him with more time.

"That's the only reason I got my job this year," Ben told Vice. "ChatGPT does, like, 80% of my job if I'm being honest."

He added: "I can just tell it to create a story, and it just does it for me based on the context that I gave it."

Ben told the outlet that he still needed to tweak the text at times.

He said he even used the chatbot to write messages to his manager, prompting the bot to write them in lowercase letters so they appeared organic.

Source D: *From an article published on by Reuters*, 9 May 2023. The article focuses on an interview with Geoffrey Hinton, also known as the 'godfather' of Artificial Intelligence (AI).*

A pioneer of Artificial Intelligence, also known as the 'godfather' of AI said he quit Google to speak freely about the technology's dangers, after realising computers could become smarter than people far sooner than he and other experts had expected.

In an interview with the New York Times, Hinton said he was worried about AI's capacity to create convincing false images and texts, creating a world where people will "not be able to know what is true anymore".

"It is hard to see how you can prevent the bad actors from using it for bad things," he said.

He further emphasised on the dangers of the technology which could quickly displace

Mrs Teo said that in the OCBC bank cases, more than 350 scam websites had been blocked, with around 52 sites blocked in a single day at the peak.

However, she said that the crooks were quick to create new websites in their scam campaigns, and that this kind of behaviour will persist.

So, using AI to help detect and block such sites, could help the government strengthen its ability to tackle scam sites and be more responsive.

"The police are working with other government agencies, such as the Cybersecurity Agency of Singapore and IMDA, to explore how such technological tools can help identify scam websites for our local context," said the ministry.

These tools would help the police to more efficiently and effectively detect and block the huge number of scam websites being put up," said the Ministry of Home Affairs.

Phishing emails are not new - current technique duplicates one template millions of times and mass sends to users. Due to the fixed templates, they are much easier for email systems to detect and warn users, or to automatically block or direct to the spam folder.

“But with AI-generated messages, it would be a lot more difficult to detect because the content looks like human written messages, and every email can look different. With this, the chances of phishing emails penetrating into individuals’ mailboxes and being mistakenly clicked on and led to malicious websites (or downloads) will be higher” said Professor Lam*.

These scam emails can now be generated even faster than ever with these chatbots, written in convincing styles free from spelling or grammatical errors so often seen in today’s phishing emails.

Apart from phishing, experts warn that the technology can also be used to write
