 - (a) Using Table 1, describe the trends in apparel exports in 1980, 1990 and 2000. [6]
 - **(b)** Account for the changes in trends in apparel exports over the 3 decades. [6]

- **2** Fig. 1 shows a comparison of population statistics and measures of development among five countries.
 - (a) What do the letters HDI mean? [1]
 - (b) Explain why the HDI may be a better indicator of a country's level of development than GDP per capita. [3]
 - (c) Describe the relationship between natural increase (NI) and GDP per capita. [2]
 - (d) Assess the extent to which **political** factors may help explain the varying levels of HDI among the countries shown. [6]

Urban Issues and Challenges

- **3** Fig. 2 shows the bid-rent lines for selected land uses in an urban area.
 - (a) With reference to Fig. 2, explain the concept of bid-rent theory. [3]
 - **(b)** Using information from Fig. 2 **and** urban areas you have studied, explain the usefulness of the bid-rent in explaining the pattern of land use in urban areas. [6]
 - (c) Suggest three possible ways in which land use in urban areas may deviate from the bid-rent theory. [3]

	(b) Give two reasons for the rapid expansion of Walmart's operations.	[4]
	(c) What do you understand by the term ecological footprint?	[2]
	(d) Using Fig.3B, describe and explain Walmart's ecological footprint.	[7]

- (a) Using examples, explain the impact of new technologies on production and labour.
 [9]
- **(b)**To what extent is it true that the economic success of newly industrialised economies (NIEs) is due to their strong government interventionist policies? [16]

OR

- (a) Using examples, discuss the concept of *production chain* and its importance in the global economy. [9]
- **(b)** 'Globalisation will lead to increasing diminution of the role of the nation-state by means of treaties, international organisations, free-trade agreements, etc.' To what extent is this true of the roles of supranational bodies in the economic development of either a country or a regional grouping of countries. [16]

Population Issues and Challenges

6 EITHER

- (a) Using examples, describe the causes and characteristics of regions experiencing underpopulation. [9]
- **(b)** 'What works in one country may not work in another'. To what extent is this statement true of pro-natalist policies in the developed countries? [16]

OR

- (a) With the help of examples, describe how government policies can affect the flow of international migration. [9]
- (b) Give reasons for, and discuss the impact of the increasing feminization of migrant labour in sending and receiving destinations. [16]

Urban Issues and Challenges

7 EITHER

- (a) Using examples, describe and explain the distinctive political, economic and social characteristics of some world cities. [9]
- (b) With reference to urban areas you have studied, outline their housing problems and assess the success of management strategies in overcoming these problems. [16]

OR

- (a) Account for the causes of socio-economic segregation in urban areas. [9]
- **(b)** Discuss the impacts that could result from the decentralisation of population and economic activities from cities in the developed world. Provide examples. [16]
