

WHY HAS IMMIGRATION POLICY INCREASED Diversity?

WHY? Low Birth Rate + Aging Population + Brain Drain

Increasing tax and economic burden on the working-age population, shrinking customer base, unattractive to MNCs, valuable Singaporeans keep migrating

bring unique cultures and most importantly come w/ skills, valuable experiences, expertise



ECONOMIC OPPORTUNITIES



WHY? MNCS EXIST IN SG

Multinational corporations like SG and thus a lot of them settle here, providing employment to immigrants

HOW?

SINGAPORE GOOD 4 BUSINESS

Ease of doing business, growth potential, stable political environment and well-established legal system

- Best Investment Potential (2014 ranking)
- Top country in Asia for Least Corruption (2014)

SO WHAT? A LOT OF EMPLOYMENT OPPS

FOR IMMIGRANTS

Foreign manpower is used in low-skilled jobs (construction, cleaning), domestic workers, and PMETs (Professional, Managers, Executive, Technicians)

SOCIO-CULTURAL ENVIRONMENT

SAFE ENVIRONMENT

- (2019) ranked as the safest city in the world
- (2020) 201 days without a crime in SG important to immigrants who may

come from unsafe countries/want to settle down and not worry about crime

COMMUNITY SUPPORT

- Lucky Plaza for Filipinos
- Golden Mile Complex for Thais

Ethnic groups of immigrants exist in Singapore, helping immigrants feel more comfortable with the country and keep their cultural roots

EDUCATION SYSTEM

- Ranked 19th best edu system in the world
- Consistently ranks top 5 in smartest international students produced Attractive to parents to bring kids here, settle down and give them many opportunities to excel

INTERACTIONS IN A DIVERSE SOCIETY

Ensure society remains harmonious, through a willingness to live together and build agreement and trust in society



WHY COMMON SPACE GOOD?

- suggested by Goh Chok Tong (former PM)
 - cultivate and enlarge an overlapping sphere of different race groups
 - better social interaction, collaboration, national identity

e.g: People's Association, OnePeople.sg -> work to create CS

EXCHANGE AND APPRECIATION OF CULTURE

 Food (fusion food, squid ink, mantou)

- Music (Western + Eastern inspired music, Govin Tan)
 - Fashion (Hayden Ng, cross-cultural influences

EXCHANGE OF SKILLS AND KNOWLEDGE

 foreign scientists share knowledge to strengthen research \cap

 e.g: Biomedical Research Council w collaboration with local and foreign scientists help discover the H1N1 vaccine



CHALLENGE IN DIVERSE Society: Prejudice and Misconception

- difference in cultural background, make incorrect judgements
 - stereotypes
- minorities hurt and feel excluded
 - e.g: Filipino "maid" stereotypes

CHALLENGES: COMPETITION FOR RESOURCES



CONCERNS OVER STANDARD LIVING

 \cap

- Fear that foreigners are taking jobs from older white-collar Singaporeans
- foreigners usually take challenging job conditions that many Singaporeans prefer not to work in
- belief that employers hire foreigners at lower cost, keeping wages low for lower income Singaporeans

CONCERNS OVER SOCIAL MOBILITY

- income gaps increase
- more rich people in Singapore
- lower income groups are affected by shifting jobs to foreigner workers who offer labour costs
- loss of jobs -> affect ability to progress up the socio-economic ladder
- SG retrains Singaporeans + teaches new skills to enable Singaporeans to stay relevant to economic demands, improving social mobility

ASSIMILATION

Immigrants are supposed to adopt the beliefs and practices of the majority group in the host country to make the identity of the immigrants indistinguishable from majority group

FRANCE'S APPROACH TO ASSIMILATION

EDUCATION

Discussion about religion are not allowed except in certain subjects (History, Philosophy), Adaptation classes for immigrant children

EMPLOYMENT

Allows immigrants to interact with other French people and allows them to gain acceptance, acquire social capital, accepted in society

NATURALISATION

Compulsory for all immigrants to undergo French language courses + civic education programme, to know the language and the culture of France



DISADVANTAGES OF ASSIMILATION

GIVE UP TIES TO THEIR Homeland

Lose language, touch with their own culture

GIVE UP OWN CULTURAL PRACTICES

 Muslim women not allowed to wear headscarves, Christians cannot wear crosses \cap



INTEGRATION

Immigrants retain their unique identities while forming common ground with groups already living in the country, letting immigrants create and adapt new elements into their identity, but allowing them not to change their identity

e.g: Ethnic Integration Policy (racial quotas in HDB, give common space), Presidential Committee of Minority Rights (check if any laws infringers on the rights of minorities

SINGAPORE'S APPROACH TO INTEGRATION



NATURALISATION

People who want to be citizens have to take the Singapore Citizenship Journey, let them get the culture



COMMON EXP

Opportunities for interactions to foster bonds and encourage locals and foreigners to develop better understanding (NS, School)

COMMUNITY SUPPORT

Events and activities done up by Grassroots to highlight different cultures



DISADVANTAGES OF INTEGRATION



JOB SECURITY PROBLEMS

- Singaporeans feel that they have to compete with immigrants
- job security compromised

 \cap

- blame immigrants for the increase in prices, constant traffic congestion, greater amount of public infrastructure breakdowns
- ev. in a poll in 2011, more than
 70 percent of singaporeans felt that their job opportunities would be reduced with more immigrants

EROSION OF CULTURE

- large no. of immigrants havve affected social cohesion
- some cannot speak english, so cannot interact
 - more new cultures, less of singapore's own

HOWO COUNTRIES MANAGE SOCIO-ECONOMIC Diversity in Healthcare?





USA Market-based approach

No single national policy guides healthcare system, does not intervene in healthcare providing

SINGAPORE Shared Responsibility APP

The government and citizens have to work together to ensure health of population 5

SWEDEN

GOVERNMENT-FINANCED

APPROACH

Provides substantial subsidies for the people, cost taken by gov

MARKET BASED APPROACH (PRO/CON)

FREEDOM TO CHOOSE

Citizens have the right to choose whatever healthcare provider they want (also mildly supported by Obamacare that helps lower SES to offord healthcare)

HIGH PRICES

insurance/healthcare providers can increase prices, have incentive to keep prices high and keep healthy rich people paying (only around 10% of americans can afford premiums healthcare providers want)



SHARED RESPONSIBILITY APPROACH

P. UNIVERSAL COVERAGE

Healthcare subsidies (CHAS, Medisave, Medishield Life) helps Singaporeans to afford healthcare



C. GROWING HEALTHCARE Demands

aging population need more infrastructure to support, 4x more likely to get injured



P. ACCOUNTABILTIY

Approach meant to encourage patients to take personal responsibility for their healthcare choice



C. RISING HEALTHCARE COSTS

unavoidable to global healthcare cost inflation



GOVERNMENT-FINANCED APPROACH



P. UNIVERSAL COVERAGE

- provides substantial subsidies and services (one day of hospitalisation for 20+ people is 9 euros)
- all citizens and EU citizens qualify for healthcare regardless of Ses, STRONG INTERVENTION FOR GOVERNMENT





C.HIGH TAXATION FOR LOW

HEALTHCARE COSTS

Need to tax healthy citizens highly to afford their subsidies, 25% for Value Added Tax, aging population, less people can pay

C. GROWING NO. OF PEOPLE Needing Healthcare

EU citizens don't pay taxes, but still get the cheap costs, more immigrants, more people who need hospital
